ATHLETE RULES OF CONDUCT

- No profanity or abusive language.
- If an extracurricular activity regularly interferes with our mandatory practices or competitions, you will have to choose which activity you will continue.
- Each team will be assigned other teams to watch at competitions, you are required to at least watch your assigned teams.
- All athletes will show good sportsmanship at all times.
- **FACEBOOK, TWITTER & SOCIAL NETWORKING WEBSITES ARE TREATED AS IF SPOKEN IN PERSON TO YOUR COACH AND YOU ARE THEREFORE RESPONSIBLE FOR ANYTHING SAID ON THESE. TRASH TALKING, BAD MOUTHING, OR DISRESPECTING TEAMMATES, COACHES, OTHER PROGRAMS OR FAME WILL NOT BE TOLERATED.**
- You are required to pick up after yourself...don't leave empty drink/food containers lying around the gym. This is your facility so take pride in how it looks!!! NO FOOD OR DRINK IN THE GYM.
- Fame reserves the right to remove any cheerleader or parent temporarily or permanently from the program if we feel any behavior is unbecoming of a FAME athlete or Parent.
- Athletes will be expected to wear FAME practice wear on the correct nights of practice.
- Athletes are expected to be at all awards ceremonies on competition days and in full uniform at awards ceremonies during competitions.
- While not competing or in awards ceremonies athletes must wear a jacket or a cover-up over uniform.
- Fame is not responsible for ANY items (including cell phones) lost in the lobby or gym. If you don't need it, don't bring it.

PARENT RULES OF CONDUCT

- Good Sportsmanship is mandatory at all competitions, practices, and gym functions.
- Under no circumstance should you enter the practice area at the FAME gym or any warm up area at any competition.
- Do not try to yell or get your child's attention on the floor during practice at the FAME gym or any warm up area at any competition.
- Do not gossip about other children, coaching staff, or other teams. If this becomes a problem it will result in closed practices at anytime and can result in you being banned from the lobby.
- Please feel free to speak to your coaches at any time; just remember to do it at the **appropriate** time. Do not interrupt practice or team meetings. Please ask to speak in private if the matter is sensitive or confidential.
- If you threaten to quit or pull your child from the program, you may be dismissed from the program immediately.
- It is your responsibility to know what is going on with your team...please check email, Facebook and website regularly.
- Please do not punish your child with practices or competitions. At that time you are punishing the entire team/program
- Never speak or approach a competition official such as a judge.
- Please respect the decisions of the coaching staff at FAME. We have years of experience and will make the best decisions for the entire team/program.
- Please be aware that FAME is privately owned and operated and should parents or cheerleaders engage in behavior that is unbecoming of a representative of FAME, we reserve the right to remove parents or cheerleaders from the program temporarily or permanently.

- Fame reserves the right to call extra practices in the 2 weeks leading up to a competition. While ever effort will be made to call these in advance, please know that situations out of our control sometimes lead practices being called on short notice.

VIEWING LOBBY

- Our lobby is open to parents and family Monday-Fridays and is closed on Sundays. You may be in the lobby on Sundays but we will have closed blinds so that athletes and coaches can have complete focus.
- Our lobby is under video surveillance at all times. Please know that inappropriate behavior by parents or family members can result in dismissal from our program at any time.
- Our Lobby blinds are closed on Sundays, Part of September and all of October, during any teams choreography session and any other times the coaches feel like the parent viewing area needs to be closed for the best interest of the progressions and or safety of the athletes.
- If individual parents are causing issues in the lobby they will be removed for no less than a 1-month probationary period. Our lobby should be comfortable, positive, and a place where all can enjoy watching their children.

ATTENDANCE, TARDINESS, AND ABSENCES

Practices are Mandatory. Athletes are only excused for severe illness, school functions that a grade depends on, and family emergency. Being an athlete on a team at FAME is a commitment. Athletes are required to notify their team coach if they are missing for any reason and receive their approval to miss practice.

Excessive tardiness and absences are both harmful and disruptive to the team and very discouraging for the coaches and the other athletes on the team. Every single person is vital to the success of the team. If a cheerleader is constantly late or is missing practice unexcused, proper actions will be taken with the best intentions of the team in mind. If an athlete misses practice **2 WEEKS LEADING UP TO A COMPETITION**, the athlete CAN be replaced by another athlete so that the team can move forward, regardless of the reason for missing practice.

SUMMER PRACTICES.... We realize that families take vacations during the summer. Please communicate these dates directly to your Coach. Practices are mandatory June 1-16th and then again after choreography. Summer practices are a great time to work on individual skills. Coaches are prepared to spend a lot of time tumbling and stunting during these practices** While every effort should be made to attend practices, all Practices **become MANDATORY After Choreography**. Please look carefully at the summer schedules for each team as summer schedules may be slightly different than normal schedules. **Inclement Weather Policy:** Every reasonable attempt will be made to open our doors for business on regular scheduled practice days. However in the event of severe weather conditions, the gym will decide whether to open or not. Notification will be posted on the Fame Central website under famecheer.com and also sent out via group messaging.

PAYMENTS, FINANCIAL OBLIGATIONS, POLICIES

- Payments are due on the 1st of each month, all payments made after the 10th will have a \$15.00 late charge added to the account per month the invoice is late.
- If payment is missed more than once, you will be required to put a Credit Card number on file at FAME and it will be charged any month your tuition is late.
- Fame accepts cash, all major credit cards and personal checks but we highly encourage everyone to pay online.
- Do not make cash payment without getting a receipt.
- Please hand all payments to the front counter staff, not to any coach or even Erica while she is coaching

- Checks: all checks should be made payable to FAME Central with your child's full name in the memo section (there is a \$40.00 return check charge). If at any time during the season you have more than 1 returned checks, FAME will no longer accept personal checks from you.
- All athletes with a balance on the 10th of the month will be sent home with a statement (you need to contact the office immediately to arrange payment).
- Monthly statements are not sent home unless you are behind, so please remember that tuition is due on the first of the month. If you provide a working email address on registration info, you will receive an email invoice monthly.
- If your account becomes more than 2 months delinquent, your account will be sent to collections, and your child will not be able to participate until your account is brought up to date.
- It is your responsibility to keep up with your account. If you do not keep up with your account we will hand statements & invoices to your child to take home.
- During All Gym Closings and Breaks Full Gym Fees still apply.
- With our new Iclass pro software system, you will now be asked to store your payment information and pay online monthly. If you cannot for some reason please speak to Erica.

FAME CLOTHING:

There is to be absolutely no creation of clothing that has FAME logo, team names or any version of its logo. FAME is a registered trademark and will be protected. We reserve the right to dismiss your athlete from the program if you are caught making, selling, or distributing any clothing or items of any kind with the FAME logo, Brand or team names.

REFUNDS

- FAME requires a **60 day written notice** if your child will be leaving the program. This notice should be emailed to Erica at famecentralgym@yahoo.com . You will be responsible for billing until your 60 day notification is up.
- Please note your account will continue to be charged until written notice is received.
- No refunds will be given for competition fees, choreography, tuition, or clothing for any reason at any time.
- If you quit the team prior to a competition you will NOT be refunded any competition fees. It takes a lot of hard work on behalf of the coaches and the team members to get a routine ready for competition. We register for competitions beginning in the summer to receive the best rates. If your child decides to quit, we must find a replacement and train them to be ready to compete. Therefore, competition fees are not refundable even if your cheerleader leaves, prior to a competition.
- If you have to miss a competition for some reason and we have to find a replacement, you will not be refunded any fees.

FUNDRAISING

- FAME will offer fundraising from June-end of August.
- All fundraisers are optional. 100% of what you earn will go towards your personal account.
- Typically we conduct sales type fundraisers such as candy, donuts, and raffle tickets....etc.
- If you have a financial hardship we recommend you take advantage of this opportunity.

PRIVATE LESSONS AND ADDITIONAL ITEMS

Privates are an excellent opportunity for FAME athletes to grow and excel their skills. While we value the results they provide they must be conducted in the following way.

- There is a \$150 flat annual private lesson fee, OR \$10 cash per lesson, OR \$45 monthly fee. You can choose which is most beneficial to you financially.
- All privates will be set up through individual instructors and are not set up through the gym.
- **Lesson Payments for Privates are paid directly to the coach.**
- **IF YOU HAVE A BALANCE OF ANY TYPE AFTER THE 10th of The Month You will NOT BE ALLOWED TO DO PRIVATES until the balance is paid in full**
- Additional items such as apparel, camps, etc. may not be purchased or participated in if you have a balance on your account. Accounts must be paid first before getting any of the “extra” things.

WALKTHROUGH DAY:

- Walkthrough Day will be held on June 1st. This is where you will come through to pick up your practice wear, purchase any fun items like sports bras bows, back packs, etc. We will also have infinity shoes available for purchase. Cheerleaders will turn in USASF forms, we will check to make sure we have your account and info all set up correctly for the entire season and you will take care of your first month bills.
- If you are registered EARLY BIRD by April 20th you can attend the VIP Walkthrough from 4:00-6:00 pm where you will get first dibs on all the cool apparel we will have and beat the lines!
- Anyone registered after April 21, will come to regular walkthrough time between 6:00-9:00 pm.
- If you are registered by May 1st we will have your practice wear pre packaged and ready for pick up at walkthrough. If you register after May 1 your practice wear will be available for pick up as soon as it arrives.

**All Cheerleaders will need to come to “Learning Day” Based on their tumbling level unspotted. We will be teaching a dance, a jump sequence, Standing and Running Tumble Pass Specific to their level that they will perform as a mini routine for their evaluation. We are looking to see performance ability, tumbling ability when performing other skills, Dance, Motions, and Jumps as performed in a mini routine. Staff will notify a student if they have come to the wrong level for their skills and they will be asked to come to the correct level for their evaluation.

Flyers will only be evaluated on stunts appropriate for their tumbling level. **Coming to a session higher or lower than your skill level does not help your placement in any way*Attending this tryout does not guarantee a flying spot. You will pay the day of the evaluation.**

2017-2018 EVALUATION PROCESS, TEAM SELECTION, and TEAMS CREATED

Due to the increasingly competitive nature of our sport, as well as, score sheet changes, we will be doing a two-part evaluation again this season. Placing each athlete correctly is crucial to the success of our teams. New this year athletes will participate in our "Learning Day," where they will be taught a dance, a jump section, standing and running tumble passes, that will all comprise a mini routine. We will strongly be looking to see what students can do when doing multiple skills at a time since this is how we perform during the season. After the learning day, each cheerleader will come back for their individual evaluation where they will perform the mini routine they learned. After all individual evals are complete, we will notify you by Monday, May 22nd which group evaluation to come back to. We have changed our evaluation process tremendously as we will be changing how we build teams this season in an effort to continue to be more competitive each season. **Please note that coming to a level higher (or lower) or wrong age group will not benefit an athlete in the evaluation process.**

TEAM PLACEMENTS AND SELECTION OF DIVISIONS

All Cheerleaders will be notified via email of their team placement on May 30, 2017. You will receive practice schedules and team details when this comes out. Fame All Stars has 14 years of experience and is a respected program in the state of Virginia and across the Country. Team placements and selection of divisions is solely up to the owners and staff at FAME. Our number one priority in building teams is to create the most competitive teams possible so our students have a successful season. Please know that we have YEARS of experience in this industry and want the best for our students, teams, and their experience with us. With this being said, we reserve the right to place teams in whatever divisions we feel they will be the most competitive and successful in. This includes but is not limited to Prep Divisions, All Star Divisions, Worlds Divisions, Restricted Divisions, or Exhibition Divisions. A team may start out in one division but if we feel through the season they need to be in a different division, we reserve the right to make that change at any time. The way our industry is growing and changing, programs across the country are using the variety of divisions to their competitive advantage, as will we.

NEW THIS YEAR!

We will have several different types of Teams. Please select on your tryout form, which type of team you prefer to be placed on. Some teams you can select, and others you will have to make based on skills. You may select more than one preference. Please know that we do not guarantee your selection. This is for us to know your preference only. You will be placed in a group based on your skills, abilities, maturity, and also based on where we can create the most competitive team.

1. **Minimal Travel Team**: This team will attend only one travel trip within approximately a 3-4 hour distance. All competitions will be close to home in areas such as Norfolk, Va Beach, Richmond. These teams will compete/perform about 7 times during the season. The appeal of this type of team is less travel and minimal overnight expenses.
2. **Travel Team**: This type of team will travel to approximately 2-3 travel comps per season and will compete/perform an estimated number of 7-9 times. Our goal will also be to receive a bid to the U.S Finals in early May.
3. **Summit Team**: With growing interest in the Summit in Orlando, FL we will be considering creating some possible teams that will be what we call "Summit Hopeful" teams. Summit hopeful teams will attend more competitions that offer summit bids in hopes of possibly earning one. Being on a team that is hopeful to attend the Summit, does NOT guarantee we will attend. These teams if created, will be incredibly competitive to make and will be highly selective. Selectivity will be based on prior commitment/attendance and behavior in our program, work ethic, skills able to throw in routines, and being the entire package for a specific level. Summit Hopeful teams will attend approximately 3-4 travel competitions during the season and may compete slightly more than the regular travel team. Athletes will have to be masters of all skills in this level. Having one level appropriate tumble pass does not make you a master of that level. Please refer to the banner in our lobby for pro status of each level.

4. **Worlds Team:** Worlds Teams will be created per usual in hopes of earning a bid to the Cheerleading Worlds. Worlds teams will be highly competitive and selective to make, and will require a great amount of dedication and commitment from athletes and parents. This type of a team is also a much higher financial commitment than normal teams. We will travel to approximately 3-4 away competitions as well as a handful of local comps. World's teams may be based out of your home gym or they may be combined with other FAME programs.

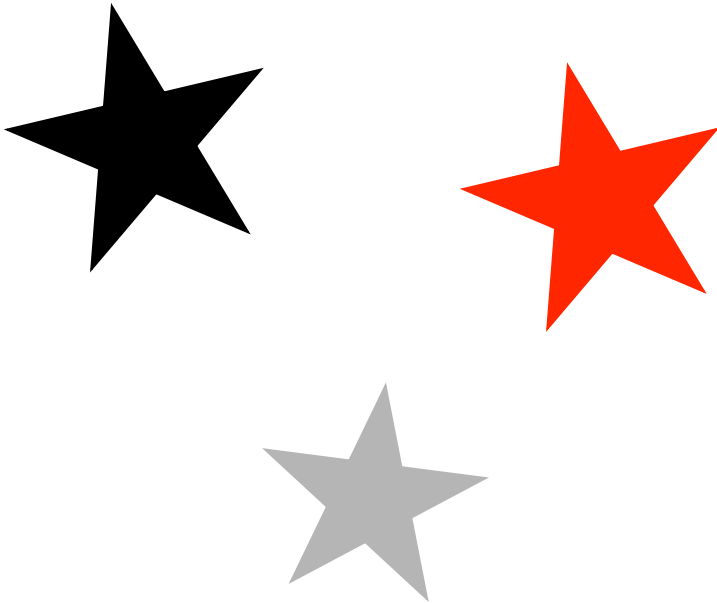
All evaluation days are closed to parents and family members. Tiny tot cheerleaders ages 3-4 will not need to be evaluated. Those Tynys that are 5 as of Aug 31st will need to come in for a quick evaluation on May 16th from 6:00-7:00 pm.

Evaluations for all levels will be low stress. We will not ask any athlete to do anything they are not comfortable doing on their own. Athletes may use equipment if needed to show skills but there will be no instructor spotting. The goal is to see athletes perform skills on their own. Athlete placements are based off of skills thrown at evaluations. Should an athlete no longer meet the required skills once placed on a specific team, they may be reevaluated and placed on a different team. We will be re- reviewing all Athletes unofficially in late JULY-Early AUGUST and we reserve the right to move cheerleaders around to different teams if need be.

We are looking forward to another successful and fun season of FAME All Stars. No matter what team you are placed on, you will receive the highest level of coaching and have an amazing experience at FAME! 😊

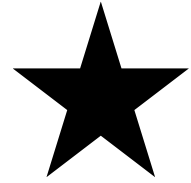
